#### Job Description Summary:

To plan, implement, facilitate and supervise activities and events in a specific program area. To involve our club members in fun, innovative and creative programs in each of our core areas to meet the needs of club members, their families and the community. Work with assistants and volunteers. Follow policy and procedures that promote the safety of members, ensure quality of programs and appearance of the Club at all times. \*\*\* **Must be 16 years or older and pass a background check** 

#### Job Responsibilities:

- Takes the lead in day to day policy/procedure and programming for a specific area.
- Understand the mission, vision and goals of the Club
- Plan, implement, facilitate, supervise and evaluate all educational programs, activities and events
- Plan and implement quality programs for our youth
- Provide guidance and role modeling to our members
- Documentation of participants in all programs/activities
- Mentor and inspire youth, adults and volunteers in the creative process
- Implement and develop curriculums that are aligned with program themes and events
- Assist in implementation of BGCA national projects & exhibits.
- Perform community outreach for specific program areas when needed
- Ability to work with club members, families, and others from diverse backgrounds
- Other assigned duties
